PUBLIC INPUT FOR THE GOOD OF THE DISTRICT

At this time Peggy Carroll presented Mini-Grant Awards on behalf of the Education Foundation to: MaryAnne Garamendi, Diane Ensley, Audrey Smith, and Jeannette Willard.

Teresa Fasola, CUEA Negotiator, read a statement to the Board advising that in no way did the CUEA Unit support the student walkout today, but noted that it reflects the unrest at Calaveras High School. Greg McGinty read a statement about negotiators' offers to meet with Board Members; Mr. McGinty also advised the Board that there used to be one Board Member present during negotiations, but this no longer happens. Student Jennifer Gilstrap, CHS Student Council, read a letter regarding the lack of after school activities because the teachers aren't available. Terra Eastin invited Board Members to attend classes with her. Alex Tate advised the Board that the boycott of classes was not teacher instigated and asked why negotiations were taking so long and why the remodeling project is taking so long. Jennifer Minton commented that "supporting teachers supports kids." Daley Tocher noted that class size was very good today. Kathy Moore, parent of a photography student, spoke in praise of the photography teacher and all the work she does for the students. Mike (last name unknown) spoke about the need for security for the photography classroom. Kevin Burton addressed the Board advising that the Drama classroom has also been burglarized too often and advised the Board that it needs to support these good teachers and address the security problem. Other comments from students were: No sheltered place to eat for students; Swim Team members must transport themselves to Sonora because no one will help them with a team; class size is too big for the Ceramics class; Students should be FIRST - not sacrificed; Can't lose our good teachers, both regular ed and special ed; Advanced Drama students will not be able to put on a production without after school help from teachers; there will be no Awards Ceremony at night - it will be during the day when working parents can't attend.

Curriculum Report

Director of Curriculum Betty White reported that the STAR testing materials have arrived and Jenny Lind Elementary blue track will begin STAR testing next Wednesday. Mrs. White also reported that she was in Modesto today attending a Reading Intervention Academy; the Safe Schools Assessment Report is here and will be presented at a future meeting; the District-Wide Choral Festival is next Wednesday, 6:30 p.m., in the high school gymnasium; Curriculum Council is meeting tomorrow.

Facilities Report

Henry Petrino, Director of Facilities, provided the Board with an update report on the bid results for the San Andreas and West Point Multi-Purpose Buildings. Mr. Petrino explained that it will most likely be necessary to reject all bids. The architect is currently reviewing the bids and will make a recommendation tomorrow evening at a 6 p.m. meeting here at the District Office. Mr. Petrino also reported that the pool is still being repaired with work being done to repair some leaks; the pool will be opened following some deck repair. We have asked for help with pool repairs through legislation and are pursuing that approach. Weather is holding back work at Mokelumne Hill Elementary, but Hertzig will begin working there during the spring break.

Transportation Department Annual Report

Transportation Supervisor Mark Fairbanks provided an annual Transportation Department report for the Board's information. Mr. Fairbanks explained that a driver training course is just being completed. There will be a lot of changes in Transportation Dept. personnel in the 2000/2001 school year with three most senior drivers retiring. Changes to the red light stop laws were reviewed and an informational bulletin from the CHP was distributed. Bus inspections are going very well and the drug testing program is also going well. Special Ed bussing is working well, though not without
