# Approval, Revisions to 2000/2001 District Calendar

MSC 4-0 (Yerman absent) to approve part 1 of revisions to the 2000/2001 District Calendar. This revision is the addition of December 27, 2000, as a classified holiday.

Discussion followed concerning part 2 of the proposed revisions to the 2000/2001 District Calendar: the addition of weekly co-planning minimum days on Fridays for all elementary schools. Superintendent Frost explained that this is really a site-based issue and that schools are coming to the Board with this proposal. Members of the audience addressed the Board with their concerns about child care during these co-planning days, potential transportation problems, appropriate use of time by staff at co-planning and loss of instructional minutes. Members of the staff from sites where weekly co-planning has been in place for years spoke about how weekly co-planning works at West Point and Rail Road Flat Elementary Schools and the benefits derived from these sessions. Board direction was given to administration to work towards developing an after-school program for students on co-planning days to help with the child care problem many parents may experience. Members of the San Andreas Parent-Teacher Group requested that the Board delay a vote on this request until later in the meeting tonight to allow them a few minutes for discussion amongst themselves. The Board granted this request and moved on to the next agenda item.
