The Board discussed the proposed transfer of the Special Education Administrative Unit and specific programs to the Calaveras County Office of Education. Superintendent Frost explained options available to CUSD and expected costs to the District.

A motion was made to reject the transfer of the Special Education Administrative Unit and specific programs to the Calaveras County Office of Education. Motion died for lack of second.

A motion was made to accept the transfer of the Special education Administrative Unit and specific programs to the Calaveras County Office of Education. Motion died for lack of second.

Following further discussion, a motion was made and seconded to transfer the Special Education Administrative Unit and specific programs to the Calaveras County Office of Education with certain stipulations to be contained in the Memorandum of Understanding: 1) The number of votes on the Calaveras County Special Education Administrative Council shall be representative of district ADA; 2) Develop a plan of action for potential other options. Motion failed to pass: 3 No votes – 1 Yes vote: Foltz, Yerman, Conway voting No; McDaniel voting Yes; Nagle absent. Gerri Conway shared a letter from John Brophy which addressed trust issues.

It was noted that the Board will continue discussion of special education issues at its special session on January 19, 2002. This issue will also be placed on the regular Board agenda for February 5, 2002.

Zerrall McDaniel commented that she hopes school is going well for everyone in this new semester.

Jim Foltz provided an update on CHS sporting events. Mr. Foltz also thanked Bill Howe and crew for the work on the athletic fields.
