CELEBRATIONS AND RECOGNITION

Beverly Boone gave a presentation about the various programs at West Point Elementary and Rail Road Flat Elementary, describing the attendance incentive programs, Mega Skills program, counseling for bullying, victims and social skills by Tanya Kiernan (available due to an anonymous donation), the Missoula Children's Theatre, and Fine Arts Day at West Point (Rail Road Flat is planning a Fine Arts Day, which will hopefully occur this Fall). Beverly also said the PTC's at both schools are very involved in raising funds for some of these programs.

CORRESPONDENCE

Mr. Campbell shared that Angie Barney took 24 students to the FFA State Conference from April 17-20. They returned with 3 awards: One for the Central Region FFA Scrapbook award, the second for the Central Region FFA "Ag in the Community 2010" award and the third award for the "2010 Superior National Chapter Award.". Two of their members were selected to be part of the FFA State Band and the FFA State talent, James Emshoff and Walt Hoyt.

Mr. Campbell gave his kudos to our Business Department. They received a positive certification on the second interim from the County Office of Education and continue to actively work to respond to declining enrollment, while striving to maintain a balanced budget.

SUPERINTENDENT'S COMMENTS

Mr. Campbell said there are only twenty-three days left of school. The adults and kids are working hard. STAR testing is still ongoing. AP testing begins tomorrow. We have about 30 students who will be taking the High School Exit Exam. Most of the students taking the Exit Exam are Sophomores and Juniors. It takes 30 days to receive the results, so any seniors taking the exam (only two or three), will come back in August or September for a small graduation ceremony.

He gave kudos to staff for all their hard work and thanked the staff members who were in attendance tonight for extending their day.
