CELEBRATIONS, RECOGNITION AND ANNOUNCEMENTS

a. Transportation Department

Andrew Peters, Manager, Transportation Department presented a review of the 2010-11 school year. He has assembled a Handbook Committee and Procedures Handbook, training has been provided for special needs drivers, more involvement in IEP's to get kids to a less restrictive environment and recruiting more subs, which allows them to do more field trips rather than hiring charters. They will be doing the Senior trip this year. We will also begin charging for home to school transportation next year.

Tessie Reeder, Manager, CUSD Fleet, described the new plug-ins, which is a filter similar to a catalytic converter that burns off the soot. This was available due to a grant written three years ago with Mr. Merrill. They are looking at going to 5% bio-diesel fuel. They are hoping the grant for bus replacements will come to fruition. She thanked Andy Peters for all he has done for the Transportation Department. He brought them together as a team, stating that bus drivers have to be strong personalities to drive a bus full of kids. Bus drivers are all leaders. Andy thanked Tessie and said she is doing an amazing job.

Mr. Peters reported that we have a new Dispatcher, Jim Daly, a new bus driver, Siobhan Fischer, two new sub drivers, Joe Grace and Sam Long. They will have two retirements this year: Butch Stower and Mary Grover. He said they have an excellent team, who are very caring and know their families and kids.

b. After School Programs Presentation

Kim Potter addressed the Board and said tonight's presentation will be about After School components of state requirements. Jackie Galica, West Point Elementary, gave a presentation on the academic hour; working with students on homework, reporting progress to parents. She mentioned that staff receives mentoring from teachers in the classrooms. Sarah Alfred, Rail Road Flat Elementary, spoke about enrichment centers, which reinforce the concepts taught in school (math, science, history and technology). Joy Burns and Karen Domingo, Mokelumne Hill Elementary, talked about the cooking they do with the children. The children love cooking, mixing, and eating what they prepare. They made the cookies for this evening's Board meeting. They make Mexican, Chinese and prepare a Thanksgiving feast to learn about cultural events. Susan Smith, San Andreas Elementary, explained how they use sports and PE. They believe children need to stay active and spend time outside. They received a Fitness Challenge grant. They instituted a walking program, whereby they walk one mile a day (younger children do less). They also make up games and the rules and the children manage to work things out. Debra Guthrie, Lori Sophia, Brooke Aleshire and Debra Roberts, Jenny Lind Elementary, reviewed their homework and enrichment program. They have local artist, Marchand, come in once a month to work with the students. They brought samples of artwork created by the students. Patty Luna and Michelle Coggin, Valley Springs Elementary, described how they use music and motion. They utilize the skills of Tim Roberson, a music teacher, in their program. Patty Luna had the Board and audience do a music/motion exercise.

Gregg Gustafson asked questions about charter schools. He said he had an opportunity to speak with Dan Lundgren last week stating that Mr. Lundgren would be asking why we were laying teachers off if we haven't spent the federal jobs funding. Mr. Campbell informed Mr. Gustafson that we are spending the Federal jobs money just to keep staffing at 30 to 1. It will save teachers jobs to keep 30:1.
