Board President Sherri Reusche gave an explanation of a study session as a time for the Board to have open discussion with each other. If the audience had any questions or input they may or may not be called upon, as the Board is conducting a study session to prioritize their goals for the district.

Superintendent Mark Campbell took the floor to provide a PowerPoint Presentation. He said he would like the Board to identify four to five goals a year for the district. These will be goals for one year as well as multi-years (3 to 5 years). They will be reviewed each year, possibly changed, as they would be evolving as our needs and priorities change. The budget is also a big piece of what will drive our priorities as well as a connection to School Site Plans and our Mission Statement.

Mr. Campbell explained that the Board held a Governance Workshop with a Facilitator from CSBA in July and this study session would be to share the outcomes and narrow down the goals to at least five.

The PowerPoint presentation reviewed the outcomes of the Governance Workshop:

- Elements of Effective Governance
- Unity of Purpose (successes, challenges and goals)
- Characteristics of Effective Trustees/Team
- Governance Leadership (structure, process and protocols)

After the presentation, Mr. Campbell called upon each Board member to give their top 4-6 goals for the district. Each Board member provided their input. The top five priorities were (not in priority order):

- 1. More diversified general education for non-college bound students (life skills, electrical, plumbing, learning how to budget, cooking, sewing, metal shop, wood shop)
- 2. Institutionalize community service for seniors and/or K-12
- 3. Reduce Class Size
- 4. Expand viable independent study and home school programs
- 5. Address our technology issues

Mr. Campbell will take these five items and work out the details with tangible steps, accountability and proposed timelines. The Board will further discuss and debate to fine-tune them along the way, as this is a fluid document of the "Big 5."
