# 1. <u>Approval, Recommendation of the Superintendent Concerning Reduction of Certificated Services</u> <u>for the 2012/13 School Year</u>

The Superintendent is recommending particular kinds of service now being provided by the District be reduced or discontinued in the 2012/13 school year.

Mrs. Bowsher, Mrs. Garamendi, Mrs. Reusche and Mrs. McDaniel said it was important for them to try and keep our class sizes low and save jobs. They expressed this as a legal obligation to meet timelines. Mr. Campbell said we will continue to analyze budget and enrollment over the next seven weeks.

Karen Wallace, CUEA President, addressed the board with concerns about reductions in teaching staff and raising class size in K-3 to 27:1. If we raise it to 27:1 we will be looking at 30:1 – that's just how things go. She said that there are areas we can cut that we have not cut. It was tough on the teachers and the kids last year. As a union they will organize against staffing 27:1.

Many other teachers addressed the Board with concerns over class size, disruption, loss of the ability to work one-on-one with students, leads to combo classes and the difficulty in teaching two curriculums, it affects Jenny Lind more than any other school, staffing K-3 with lower ratios leads to better prepared students in the future, chaos the first week of school and difficulty dealing with behavior problems.

Parents spoke about their concerns with the disruption making changes after the school began caused this past. Have we thought about bussing students from one school to another (i.e., where there may be only eight 3<sup>rd</sup> graders in one school)?

Mrs. McDaniel thanked everyone for their comments and there were very good points and she thinks everyone in the room wants the same things for our kids. They have more time until they have to make a final decision and will study the budget and enrollment further. All the teachers and administrators work very hard and the board is sensitive to these issues, but for now they must vote on a resolution and hope they will make the best decision in this regard.

Through this program, the CSBA also invests the monies not currently needed by the school district for cash flow purposes to maximize the opportunity to realize a profit on the entire transaction. Through analysis of our cash flow for the 2012/13 year, participation in the California School Cash Reserve Program will help the District maintain a healthy cash flow through the entire year.
