1. Revision to the Management/Supervisor/Confidential Salary Schedule

c. **Proposed Price Increase for Food Sales**

Annual Paid Lunch Equity (PLE) factoring is a method which school districts verify they are covering the cost of full paid meals without encroaching upon the dollars received for school lunch reimbursement from the Federal Government. The current PLE indicates CUSD should raise prices by 25 cents per meal. Therefore, we are recommending the increase begin effective the 2014/15 school year. PK-6th grades will be \$2.50 per lunch and 7th to 12th grades will be \$3.00 per lunch. It was recommended the Board approve this increase.
