# 14. Public Comments

At this time, visitors may address issues that do not appear on the agenda. Lorraine Angel, teacher and CUEA President, recapped that the Governor's budget that recently came out. We (CUSD) came in under budget in 2013/14, and we had \$1.3 million more than was projected. That's a good thing to start off the school year with. The 2014/15 budget is in the second year of Local Control Funding. We got our 29.15% toward closing our gap. We also got the .85 COLA, which is actually the cost of doing business. In 2015/16 it is projected we will get a 1.58% COLA and they are looking at closing the gap at 32.19%. More good news is we should have received all our deferrals for 2014/15. It looks like in the 2015/16 budget we will get the 5/5/9 apportionment, where you get 5% in July, 5% in August and 9% each month thereafter. There's even better news because after Governor Brown came out with this budget the accounting office said there's another \$2 billion and most of it will go to schools. She believes we will get that 32.9% to close that gap but is a little concerned (Mr. Crancer said we will get the grade span adjustment funds) knowing what our class sizes are now and with teacher reductions they are going to get larger. She would like to know when we are going to adjust cuts based on this changing financial picture. She would be happy to share the information she received.

Denise Gustafson would like a report/update or any decisions made by the Budget Advisory Committee.

Superintendent Campbell said he could send her the notes from every meeting and her husband, board member Gregory Gustafson, also has them, as Mr. Campbell emailed them to all the Board members. He asked her to provide her email address to his assistant Shirley Bell. She agreed to do so.

# c. Annual Developer Fee Report

In accordance with Government Code 66006, an annual listing of fees collected by developers and homeowners that are either constructing new buildings or expanding on current buildings must be presented. During the fiscal year, the charge per square foot was \$3.20 for residential development and \$0.51 for commercial development. Funds collected were used for the obligations of the District's Certificates of Participation (COP) notes. A statement of revenues and expenditures for the 2013-14 fiscal year was presented September 2014 in the District's year-end financial statement and is included for reference.

# c. 2013-14 Independent Audit Report

Per Education Code 41020, a report of each local educational agency audit for the preceding fiscal year shall be filed with the Calaveras County Office of Education, California Department of Education, and the State Controller by December 15<sup>th</sup>. Further, per Education Code 41020, by January 31<sup>st</sup> of each year, the governing body of each local educational agency shall review, at a public meeting, the annual audit of the local education agency for the prior year.
