The meeting of the Calaveras Unified School District Board of Trustees was called to order at 4:30 p.m. at the District Office, Board Room.

Allen Lujan, citizen, read a prepared statement which said he felt the vote to name the Performing Arts Center (PAC) after former Superintendent Jim Frost was premature and presumptuous. It did not reflect the will of the people but rather Superintendent Campbell's personal view. He feels this is an abuse of power and position. He believes the CUSD staff and community at large no longer trust the Superintendent. He wishes the same energy and determination could be used to solve the Jenny Lind Elementary special education crisis; keep small schools open; hire and retain highly qualified teachers and support staff; attract and hire highly qualified directors and managers to the district office; resolve to eliminate the bullying epidemic in the district by vowing to recognize and eliminate bullying and aggressive behavior from your own interactions with others and completion of a Toyon kitchen. To work with all Board members rather than spending thousands of taxpayer dollars to defame and entrap those who have different priorities and points of view. He called Mr. Campbell a "controlling king," and asked for his resignation.

#### 18. PERSONNEL

#### a) Certificated Report

Vice President of CUEA Renetta Hale reported that on April 11 CTA and NEA Board members came to Calaveras County but, unfortunately, when they go to our side they only had time to visit the high school. They met in Murphys for dinner, where she met some people from Vallecito and learned about the "Go Math" program. She also found out San Andreas Elementary is looking at a different math program, so they are going to pilot both. Their next site rep meeting is May 20 with a Round Table on May 21. They were invited to the food bank and were impressed with the facility. They were informed they collected 1,400 pounds of food with the canned food drive they recently held.

She turned the floor over the CUEA President Lorraine Angel. Ms. Angel stated that in late July 2014 CUEA members were surveyed regarding the chaos in the district business office. At that time a large majority of the members wanted a vote of no confidence for financial officer Titia Ashby and Superintendent Mark Campbell. In September Ms. Ashby resigned and the vote of no confidence for the Superintendent was put on hold again. Over the last 8 months members have continued to request a vote. In April a vote was conducted and a question was asked: Are you confident in the ability of the Superintendent to provide effective leadership for the district? The results are as follows:

- 17% of the members are confident in the abilities of the Superintendent to provide effective leadership for this district
- 74% of the members do not have confidence in the Superintendent to provide effective leadership for this district
- 9% of the members abstained.

This is a result of 98% of CUEA members casting ballots. The teachers are asking at this time that you take this information into consideration when making decisions for the coming year.

#### b) **Classified Report**

Melanie Hernandez, the CSEA bargaining committee chairperson, read a statement she drafted on behalf of CSEA. She requested the Board's yes vote for the tentative agreement reached on March 26 at the PERB hearing. CSEA has ratified the Tentative Agreement. While they have agreed on this settlement, it is just a "settlement." They are all well aware of the concessions they have made. This agreement is viewed as a temporary solution and they would like the District's acknowledgement that there are outstanding provisions still due to Classified. What they have agreed to concede cost their union members \$460,000. This is an ongoing savings to

the district's budget. Their concession has allowed the district to maintain the operation of all the schools. This savings will help clean up the fiscal mess and the financial decisions of the past years that have cost us all. You are now the stewards of this agreement, assuming it passes. When you are asked to make a financial decision please ask yourself if this is going to harm Classified first. After all there have been no other concessions by any other group of employees in the district. They will be watching and challenging. They do not expect the district will be creating new management positions or hiring more Certificated than is absolutely needed, or providing increases to any other group prior to projecting a positive budget for 3 consecutive years, and, therefore, honoring their agreement. They are waiting for a time when they are given what is due when the budget allows. They hold this Board and administration accountable toward making an effort to attain the minimum reserve of 3%, at which time the district will be required to implement salary and benefit increases due to them per the settlement agreement. They expect the district to view this as an outstanding debt that takes priority. They expect to be treated fairly, holding the district accountable to do right by their employees.

The Calaveras Unified School District Board of Trustees wish to recognize our school district's Classified employees with the adoption of Resolution 2014/15-28, declaring May 17-23 as Classified School Employee Week.

Paraeducator Marcelle Papp questioned why this agenda did not have the approval of the Tentative Agreement on it.

Kassandra Booth, Fiscal Director, explained that the TA was not ratified by CSEA until April 29. This did not provide enough time for the County Office of Education to get their 10 days to review and write a response to the AB1200 prior to the May 5 Board meeting. However, the district would bring the AB1200 to the May 19 Board meeting for a public hearing and

plan to bring the AB1200 and the Tentative Agreement to the May 19 Board meeting for board approval.
