The meeting of the Calaveras Unified School District Board of Trustees was called to order at 5:00 p.m. at the District Office, Board Room.

The meeting was called to order at 5:01 p.m.

They will help guide us on a decision for a new mascot. This will not be the top priority for CUSD, but it will be a priority. We will respect everybody's voice and rights throughout the process.

Board member Kelly Smith wished to recognize the CUSD Food Service Staff. She said every person who works for the district has an impact on children. She shared a story of a child in her 2<sup>nd</sup> grade class when she used to teach who did not get excited on Friday's for having a weekend off because that child said the only time they got to eat meals was at school. At that time the school's food service staff began to prepare packed lunches for that child to bring home for the weekend. She thanked our food service staff for their dedication and hard work and as a token of appreciation purchased a cake to have served to them. She also wished to recognize Jennifer Merrill, who has been with CUSD's Food Service the longest of all food service staff – since 1986. She had a gift for Jennifer, who could not join us this evening.

# 14. Public Comments

At this time, visitors may address issues that do not appear on the agenda. This is not the time for discussion or deliberation nor can action be taken by the Trustees or Superintendent unless the matter is placed on a subsequent agenda. Teacher Sharon Schlegelmilch addressed the Board with her concerns regarding class sizes being too large; especially in the TK-3 grades. It's very difficult to teach young children when you have class sizes that are 30+. She used a stick with clothes pin on it with each clothes pin representing a child. Six years ago she had 20 kids and today she has 27, but some of her colleagues have 33 1<sup>st</sup> graders. There are other classes exceeding the 30 board policy maximum. It's hard to meet their needs when several have IEPs and language learners. There are also several combo classes exceeding 30 kids.

Parent Ben Stopper also has concerns about the large class sizes. He believes there are 33 in Ms. Erbeck's class now (Jenny Lind Elementary). Ms. Erbeck does a great job managing her class. There's a Kinder/1<sup>st</sup> split class with 30+ kids – seems like a lot to handle and he recalled that the Board said, last year, there would not be 30+ kids. He would like the Board to look into this for next year since it's obviously not going to change this year.

Lorraine Angel, teacher, said VSE and JLE are the 2 schools that are 30 point something in their class sizes average, so there are classes that are over 30 at both of those sites, and other sites as well.

Terri Henderson, Food Service Driver, said she remembers a time when we had full time paraeducators in our Kindergarten classrooms. It might be a good time to bring the full time para's back to the Kindergarten classrooms.

Renetta Hale, teacher, said it was not just Kindergarten classes who had paraeducators. The first year she was hired was the first year of Class Size Reduction. Everyone used to have a paraeducator with 30 something kids.

Teacher Sharon Schlegelmilch said one of the remedies in the contract for class size overage is to have a paraeducator assigned to the classroom. Combo classes should be no larger than 28 class size, per the Board Policy.

#### 1. Science Camp

Trustee McDaniel said there will be CUSD teachers representing science camp at the Board meeting next month and well as discussing outdoor education.

#### b) Approval of PresenceLearning Services Agreement

Given Speech and Language professionals are in short supply and high demand, CUSD will contract with PresenceLearning to provide the necessary services to our special education students. PresenceLearning will provide Speech and Language services to CUSD students through an online platform at an hourly rate of \$78 per hour with a \$78 per student installation fee. We are estimating the contract not to exceed \$100,000 for the year. Special Education funds will be used to pay for this contract and already included in the budget.

Jan Kendall, Director of Special Education, answered questions regarding the way the program works. Ric Stitt, Chief Technology Officer, said the technical challenges have been addressed/fixed. There were concerns about where these sessions will occur. Each site will make that determination and the Tech Department will make sure the accommodations are met.

#### c) Developer Fee Annual Report

Per Government Code 66006(b), school districts are required to prepare an annual report of developer fees collected. The Developer Fee Annual Report was presented by Fiscal Director Kassandra Booth. She answered questions reiterating that these fees may only be spent on new facilities, expansions. The way the money is spent has to have a nexus to the origin of the fees – new homes or home expansions or new commercial business/expansions in relation to new children enrolling into our schools and providing facilities to accommodate the students. These funds cannot be used for maintenance of our facilities.

#### **BUSINESS - CONTINUED**

CUSD is paying its COP payment with these funds. Ms. Booth answered a question about our COP debt and stated that our payment was approximately \$500,000, so we still had to take \$200,000 out of our general fund to meet that debt.

#### d) Developer Fee Justification Study Contract

The last Developer Fee study completed for Calaveras Unified was in 2012; however, this study should be updated every two years. Due to the increase in residential development activity, CUSD would like to contract with California Financial Services for an updated study to justify an increase in our developer fee rates. Currently, CUSD is charging \$3.20 for residential and \$.051 for commercial per square foot. The anticipated 2016 rates are \$3.60 and \$.058 per square foot. The total cost of the study is \$8,500 and will be paid by the district's capital facility funds.

Trustee Smith said she did not want to raise our developer fees. She believes if we keep our fees the same we may be able to attract more families to our area; thereby raising ADA to the district and increasing our revenue.

Trustee Reusche believes we need to increase our developer fees if we are eligible for it, so we can reduce the encroachment out of our general fund we've been using to pay our COP obligations. We used to be able to pay our entire COP's payment with our developer fee revenue but when we went into the recession we began hitting our general fund pretty hard. Increasing developer fees, she believes, will increase revenue to the district and allow us to have less impact to our general fund – funds that are not restricted.

#### f) Request of Allowance of Attendance Because of Emergency Conditions – J13A (35-49)

We are recommending approval of a Request for Allowance Because of Emergency Conditions, J13-A, for school closures of all sites due to the Butte Fires. This includes apportionments be maintained and instructional time credited. A Material Decrease is also being requested for Calaveras High School, Toyon Middle School and Gold Strike High School during the emergency evacuations on September 10, 2015.

#### Karan Bowsher

Trustee Bowsher hoped everyone had a good break and excited to be back. There is also one scheduled at Ironstone on November 1. She thanked everyone for attending.

#### **Gregory Gustafson**

Trustee Gustafson congratulated the food service employees again. He hopes everyone is doing well after the fire. He heard on one street that was surveyed that only 2 of 16 homes had insurance. He knows FEMA is kicking in and all the other resources will be there but it's still a long, hard process. He's been through earthquakes and sometimes it takes a year to get a permit to rebuild.

#### Zerrall McDaniel

Trustee McDaniel Welcomed everybody back. She said kids are pretty resilient. She wanted to remind people about the Trunk or Treat and San Andreas Town Hall Halloween Carnival. It's exciting to look at the Winter Concert schedule and see 4 of them will be at our new Performing Arts Center.

#### Kelly Smith

Trustee Smith once again thanked the food service staff and hoped they enjoyed the cake. Next time it's her month (it will be March 2016) she is open to any thoughts you may have for someone who we can honor. She knows there are a lot of people who really work hard and maybe go a little under-appreciated at times. She said thank you for everything everyone does.

#### Sherri Reusche

Trustee Reusche said it is National School Bus Safety Week. We have to make sure we are careful with our school buses and make sure we stop for them and are nice and kind to our bus drivers. She addressed Sharon Schlegelmilch and said what Sharon said really resonated with her. She was planning to say something before Sharon's public comments because she, too, is very concerned about the class sizes. She went to a Unity Conference in San Diego and attended a very interesting workshop on why kids need to read by the 4<sup>th</sup> grade. What terrified her was a man who stood up and said he worked for the prison system and there are prisons that look at the 3<sup>rd</sup> grade reading scores and if the kids are not reading, they build prisons based on the illiteracy. That frightens her and to have a large class - you have to teach kids to read and when you have 30 kids in a class it's really difficult. She remembers being in Mrs. Riggio's class and watching her do her magic in teaching them to read, and they had parent help in there and it's tough. It does resonate with her. However, it bothers her that we had to spend over \$800,000 on air conditioners and she would really like to see us talking about moving our calendar so we can take some of that money and put it into our classrooms to reduce our class sizes. She knows the calendar is sacred – she understands that – but it's a lot of money to spend on the air conditioners. She just wanted to throw that out there and will bring it up again. It's something we need to discuss. She doesn't know when we can discuss it or when the calendar is up. She wants to make sure every little bit is put into our classrooms – whether we have paraeducators, whether we have another teacher – however we do it. She knows Jenny Lind and Valley Springs get hit hard and Jenny Lind gets hit the hardest sometimes because of the way the numbers fall. Not all kids come in groups of 25. She wants to make sure we give every opportunity for every student that we have in our TK-3 a chance to read.

It's so important. We want them to be lifelong learners so that when they get to high school and do science and all those wonderful things that they are well-educated.
