4. Presentation of the Initial Proposal from Calaveras Unified School District to the California School Employees Association, Chapter, 405, for the 2016/17 Successor Agreement
The current collective bargaining agreement between the Calaveras Unified School District (CUSD) and the California School Employees Association (CSEA), Chapter 405, will expire on June 30, 2016. This proposal is being presented for initial disclosure to the public to allow for public comment prior to the start of negotiations.

Accounting Assistant Vikki Lacey addressed the Board, as the Board is being presented the sunshine negotiation items for CSEA and CUEA. Ms. Lacey is in the "Classified Confidential Employee's" unit, which is unrepresented. This unit consists of 5 employees. When the teacher's unit received their ongoing compensation package at the start of the 2014-15 school year, so did the unrepresented ROP teachers, who work off a separate salary schedule and are not members of CUEA. Their Classified Confidential unit respects the Board's prioritization for the implementation and completion of the CSEA negotiated package but wish to remind the Board their unit has not yet received any type of compensation for salary or benefit increases for the 2014-15, 2015-16, or moving into the 2016-17 fiscal school years. As such, they would like to request the Board give the Classified Confidential unit some assurance they will support them at the same level of recognition and commitment demonstrated for CSEA and CUEA and prioritize awarding them increases to salary and benefit packages before any other represented or unrepresented unit receives any further financial compensation.

Trustee Reusche clarified that the administrators observe and evaluate these teachers. There are a lot of steps that each teacher fulfills in order to get to this point. The Board's job is to ratify them. She doesn't want it to appear they have lumped everything together and the Board is just swiping the slate clean. There is a substantial process that occurs for these teachers to get to this point.

Board President McDaniel said all of these teachers, and a counselor, have been recommended for tenure, so that's what they (the Board) are doing.

Trustee Gustafson had the same comment again as for the tenured group. During the Study Session they had a discussion regarding the Board requesting personnel files. They were given a response on how the Board has to conduct themselves when requesting files. He believes that he and Kelly Smith would like the opportunity to see the files if they had any questions about any individuals so it's not just a bulk appointment. They were told they need to request it through the Board President, then to the Superintendent and if all the Board members wanted to see it, then they could look at the file as a Board. He doesn't think they are being fully granted their due process.

Trustee Reusche said they do have to abide by the AR 4112.6 which tells them when they have the right to look at a file. Usually it is a "need to know."

Trustee Bowsher asked Trustee Gustafson whether or not he asked for a file and was denied. Trustee Gustafson said he did not in this case. Trustee Bowsher said she believes that's what they discussed at the recent study session. They could ask Board President McDaniel to have it at closed session so they could all look at it at that time.

Trustee Smith said there has been some communication since then stating they would be given sections of the files. Trustee Reusche said it is Education Code and not just somebody's opinion.

Trustee Smith remembers last year asking if they could receive a little summary on these individuals.

Superintendent Campbell reminded the Board that on July 21 he presented them with an overview of every administrator on this list. It included areas of strengths and areas and challenges they are working on in their evaluation. He also emailed to the Board two weeks prior to that meeting in July 2015. He informed them that when he had the evaluations completed he would send them to them in advance of closed session and in closed session they would discuss his evaluation of his team. He would hold this team up against anyone, anywhere. The information was brought forward, but if at any point in time during the year there are concerns, real or perceived, with his administrative team, he would welcome the opportunity have that conversation in closed session. However, next time he email the information to for a second review a little closer to the vote.
