Renetta Hale, Vice President of CUEA, and teacher, gave each Board member a handout regarding Prop 30. They have a coalition made up of education, labor, healthcare, and community groups to file the Child Education and Healthcare Protection Act. It is a temporary extension on the income tax rates on the wealthiest Californians approved by the voters with Prop 30. The extension only affects the top 2% earners of the state and will automatically expire after 12 years. It is expected to raise \$8 to \$11 billion a year and will go directly into a special fund for education (K-12) and community colleges and for other special services such as healthcare and invest in the rainy day reserve fund. Up to \$2 billion will go into healthcare for low income children, seniors and family.
