Lorraine Angel, Teacher and President of CUEA, reported they had their last site rep meeting on May 11 and Round Table on May 12. The teachers are busy with end-of-year performances, open houses, etc. It was fun to see all the things at the fair that our kids have done, and it was a CHS student who won the Miss Calaveras title. Tomorrow night she and some other CTA members will be accompanying teacher Dan Stoddard to Sacramento where he will be awarded a WHOO (We Honor Our Own) Award, for his local service to the union. Teachers are planning for next year and still have some concerns about understaffing at some of our larger sites and class size at CHS in some particular subject areas. There is great concern about SPED coverage at the high school; although she knows there are postings out there but doesn't know what kind of "nibbles" we are getting. Staff is happy to work together with the District in planning professional development for next year. They have enough signatures for Prop 30 to be on the ballot.

Legislature decides what needs to be done for education – not educators. She serves as a rep on CTA State Council. She is on one committee of about 20 CTA committees. Their committee looked at 22 Bills that involve some aspect of education. Their committee looks at things that involve safety and school management. They saw a lot of "mandates." We need to be aware that these proposed mandates could dip into our LCFF funds. Even though the Bills propose some good things, we can't afford to support them with our LCFF funds.
