

**PARKING**

**VEHICLES AND PARKING - CALAVERAS HIGH SCHOOL PARKING POLICY**

- A. The following regulations apply to any vehicle being operated or parked on district property:
  - 1. The speed limit on all campus parking lots and driveways is 5 miles per hour.
  - 2. The speed limit on all district owned roadways is 15 miles per hour or less when road or safety conditions require lower speeds.
  - 3. No vehicles are permitted on inner campus walkways or roadways except for vehicles delivering supplies and vehicles belonging to the school district while in performance of maintenance, deliveries, etc.
  - 4. Roadblocks, barriers, or stanchions may be placed at any point necessary for safety or convenience. Removal of these roadblocks, barriers, or stanchions is prohibited.
  - 5. The use of skateboards, roller skates, mopeds, or bicycles is prohibited on school campuses except in authorized activities.
  
- B. Parking Regulations
  - 1. Parking stalls marked "Visitors" are solely for visitors. Students, staff, and faculty are prohibited from parking in these areas.
  - 2. Parking is prohibited in loading zones, posted areas, or along red curbing and/or red lined areas.
  - 3. Vehicles are to be parked in properly marked stalls only. Backing into or taking up more than one parking stall is prohibited.
  - 4. Physically handicapped students may be given special parking privilege by approval of the school administration.
  - 5. Motorbikes, motorcycles, and other two-wheeled motorized vehicles should park in a regular stall.
  - 6. Persons using parking facilities shall observe the distinction between compact and large spaces, and be wholly parked within marked stalls.
  - 7. No overnight parking is permitted without prior approval.
  
- C. Parking Permits
  - 1. All student drivers will be required to register all their vehicles, which are regularly parked on campus.
  - 2. Vehicles regularly used by students shall have permits properly applied and displayed from the rear window of the vehicle, or from the rear view mirror (as determined by administration).
  - 3. Student are only allowed to park in areas designated as "Student Parking."

4. Pursuant to the California Vehicle Code Section 21113A and based on reasonable suspicion, Calaveras High School administration will search vehicles of students which are parked on our campus.
- D. Violation of Regulations and/or California-Vehicle Code
1. Violators will receive a Calaveras Unified School District Traffic Citation issued by school district personnel designated by the superintendent, by officers of the Sheriff's Department and California Highway Patrol, or other law enforcement agencies.
  2. Violation may result in the denial of permission to operate or park a vehicle on school district property.
  3. Vehicles parking in prohibited areas that block the flow of traffic, fire-fighting/emergency equipment, driveways, roadways, or in posted "No Parking" zones will be towed away at the owner's expense and at no responsibility to the school district. (CVC 22702)
  4. Vehicles abandoned on school property for over 72 hours without prior authorization may be removed at owner's expense. (CVC 22702)
- E. Enforcement of Regulation
1. Erecting and maintaining signs identifying the parking area, speed limits, traffic flow, etc.
  2. Marking and identifying parking spaces, including any spaces specifically reserved for school officials, handicapped persons, visitors, delivery, and service vehicles.
  3. Supervising parking areas to warn or take appropriate action against violations.
  4. Providing each driver with forms and procedures for registering and identifying persons who are permitted to park in designated areas.
- F. Posting
1. Parking areas shall be posted with permanent signs, or notices painted on the pavement or on the curb.
  2. Temporary posting may be used from time to time as required.
  3. Posted parking signs and notices in place on the effective date of this regulation are hereby adopted.
- G. Removal of Vehicles
- Vehicles may be removed from campus and stored at the registered owner's expense under the following conditions:
1. The vehicle appears to have been abandoned.
  2. The vehicle does not display a valid license plate.
  3. The vehicle is parked so as to cause an obstruction or hazard.

4. The vehicle does not appear to be owned by a student or employee or parked in the visitor's or guest lot in conformity with the foregoing regulations.
- H. Instructions by Safety Personnel
1. In extraordinary circumstances, district personnel may direct drivers to follow instructions which may vary from the regulations heretofore set forth.
  2. All drivers shall follow such instructions, even though they deviate from foregoing regulations and, in that event, they shall not be cited for the apparent violation of the usual regulations.
- I. Parking Citation Review Committee
1. Persons receiving parking citations shall be afforded the option of having the citation reviewed by a site principal or principal's designee.
  2. The principal shall develop procedures to implement this section.
- J. Appeal
1. The decision of the principal shall be final.
  2. Should the person wish to contest the citation beyond the school district's governance procedure, an appeal may be submitted to the municipal court by the school district upon request by the person issued the citation.
